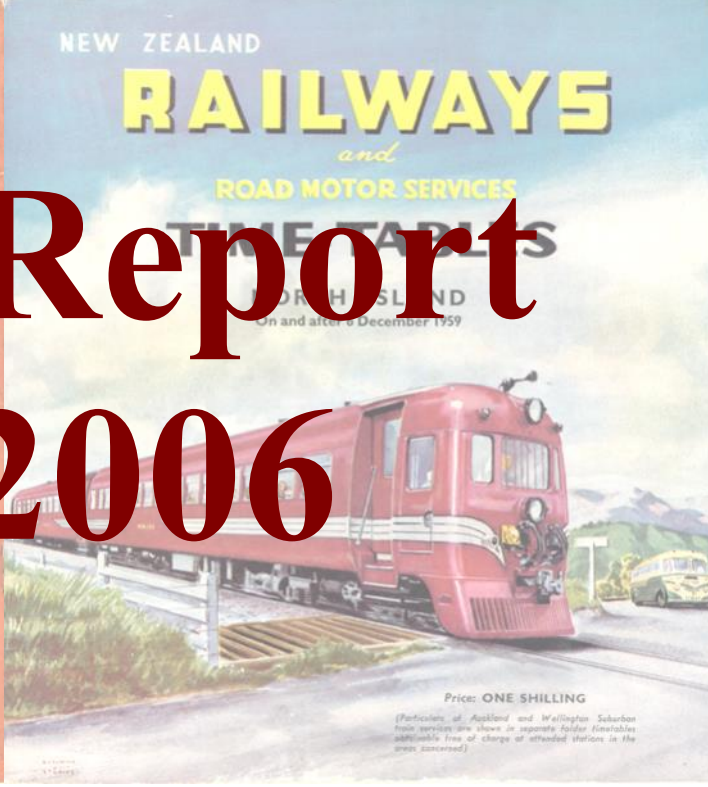

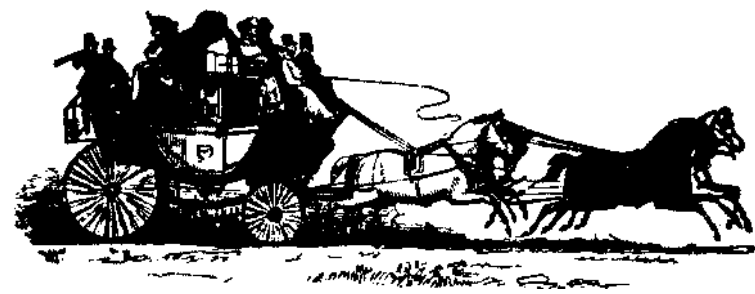

# President's Report 2005-2006

**GEOFF LAMBERT**

The 2005-06 AATTC year was an interesting and productive one for its members and office bearers. Although AATTC is a tiny organisation, in a niche market, it “bats” at a higher level than its numbers might suggest. Originally founded essentially as a club for railway timetable collectors, it has expanded to include all other modes of transport in its ambit and its membership has a high proportion of transport professionals, whose principal interest in timetables is as tools for transport management, rather than just as collectibles. A recent media story went so far as to describe AATTC as “Australia’s leading timetable experts”. The AATTC and its members acted in an advisory role to several print and electronic media outlets on timetabling problems in Sydney and Melbourne, and we are now on the media’s contact list for when timetabling issues arise— which is often these days

But the “timetables as collectibles” focus still thrives within AATTC, as evidenced by the interest in our auctions and in the grab-boxes at branch meetings. This month, the ABC “Collectors” TV program will be running a segment devoted to the hobby, featuring our Public Officer and Auctioneer, Stephen Ward.

The machinery- if you can call it that- of the Association has worked well during my tenure, with regular Committee meetings and all functions being carried out professionally. The Committee have been a pleasure to work with and have taken on all the numerous tasks which get doled out at Committee meetings with zeal and in a timely manner. To each of the branch convenors, I owe a debt of gratitude for organising meetings and events and engendering a degree of membership participation that is the envy of other voluntary organisations.

I congratulate particularly the extra-Committee position holders for the work they have done. Special mentions are due to:

**Lourie Smit**: Webmaster- for maintaining and updating the AATTC web-site on almost a daily basis. The AATTC web-site is the source of many enquiries from the public, the media and the transport fraternity. I feel we are miles ahead of the NAOTC on this and, in three weeks time, I shall be attending NAOTC’s own AGM in Scranton to urge them to emulate us.

**Duncan MacAuslan and Steven Haby**- Table Talk Editors- for maintaining the high standard and timeliness of our news magazine.

**Dennis McLean**-Membership Officer- for maintaining our membership database, recruiting new members and attending to the needs of all our members through personal contact.

**Len Regan**- Distribution Officer- The Distribution List activity of AATTC was one of the main reasons why I joined the organisation in the first place. Len Regan has now elevated it to a positive art-form, and it must surely be one of the principal means of attracting and holding our members. Len has introduced streamlined systems and a huge increase in the amount of stock available and distributed— there can be up to 16 pages of lists of timetable material for distribution each month. Len’s highly analytical reports to the Committee serve as a *de facto* monthly survey of the interests of our members and supporters. Len also coordinates the grab-box distribution between (at least) Brisbane and Sydney in association with his DL task. All of our member donors to the Distribution List are also essential to make it work and I would like to thank in particular **Hilaire Fraser** for his effort in organising donations from a wide range of transport operators.

**Stephen Ward**- Auctioneer- Auctions are the icing on the AATTC cake and another reason why many people become members. They are essential to AATTC’s financial well-being and offer a facility to members to trade timetables among themselves.

Last, but not least, I would like to thank all the members who participated in meetings, responded to our pesky enquiries and forwarded timetable news to the magazines to keep them brimming with relevant information.

I have been President for a little over 1 year, having ascended to the position late in the 2004-2005 year and then being elected for a further year. I am generally in favour of a maximum of two year’s continuous duration for positions such as President, in order for the organisation to remain fresh and vibrant. I shall re-nominate for the position for the 2006-2007 AATTC year, but would gladly withdraw if another member would like a go at the job.



# Treasurer's Report, 2005-2006

**DENNIS MCLEAN & GEOFF LAMBERT**

This summary report has been written by the President because our Treasurer Dennis McLean was unavoidably diverted by both a house move and by being appointed a Returning Officer for the Queensland state election to be held on September 9<sup>th</sup>. The report has, however, been approved of by the Treasurer. It is based on the official Annual Statement, which appears overleaf. The accounts have been prepared on an accrual basis this year, as compared to the cash accounting methods used in previous years.

## **Summary**

The AATTC is in quite a healthy financial position, a situation that has prevailed for some years now. However, in the 2005-2006 Financial Year, the net result of our operations was a cash loss of some \$3,353. This represented about 18% of our initial cash holdings of some \$19,000 at the start of the year, and obviously could not continue indefinitely. The main reason for the "loss" is a change in the number and performance of our Auctions- there was only 1 in 2005-2006 and the return from it was less than in previous Auctions.

AATTC has no formal policy on whether it should make a profit or a loss, what its cash reserves should be and how its costs should be covered, but the *de facto* policy is that : it should break even; it should hold one year's operating costs in reserves and; its costs of operations should be met largely from membership fees (about 80%) and from the profits from Auctions (about 20%). The Committee has decided to juggle the timing of auctions in the 2006-2007 Financial Year, increasing the number to 3 (August, January and June), so as to "catch up" on the 2005-2006 result. The Committee considered the option of increasing membership fees as an alternative method, but this was not considered necessary.

## **Expenditure**

AATTC's major costs are in the production and mailing of its magazines and newsletters, which totalled some \$14,000 in 2005-2006. Full details of these costs, and comments on them, can be found in the Production Manager's Report on page 11. These have generally been satisfactory and on target, even below target. The printing costs are rather low by normal standards. This is because the magazines are not offset printed but are, in effect, photocopied by the printer. This cuts costs to about one-third of "normal" printing rates.

In 2005-2006, both the income and expenditure of the Distribution Service increased significantly, due to the vastly increased scope of operations initiated by our Distribution Officer, Len Regan. AATTC considers that the cost of running the Distribution Service is a corporate expense, to be met by normal sources of income and not by the Service itself- i.e. it is not required to turn a stand-alone profit.

It is worth noting that some operating costs of the Association are met from the pockets of some of the Committee- thus the bottom line could worsen were this practice to cease, but the numbers involved are not very large.

## **Income**

Income in 2005-2006 was normal for Membership, but decreased slightly for Retail Sales (one shop ceased to take our magazines) and for the Auction (as explained above), and increased markedly for the Distribution Service.

# Notes to the AATTC Inc. Financial Statement for 2005-2006

**DENNIS MCLEAN**

This year we are reporting the financial results for the first time as Accrual Accounts.

- (1) The cost of printing Table Talk, The Times and the Members Newsletter has increased this year by approximately \$1100.00. This can only be attributed to the higher cost of printing and the occasional large issue of one of the Journals.
- (2) Mailing costs have reduced slightly for the 2005/2006 year, with a reduction of \$130.00.
- (3) As well as the cash operation of Distribution Service being show in the Financial Statement, it also has a separate statement where the overall operation Including Stamps is outlined.
- (4) As only one auction was held this year the profit amounted to only \$457.00.
- (5) Subscriptions received for the year totalled \$7235.04.
- (6) Again this year, advertisements were placed in Transit Australia publicising the AATTC with a view to increasing membership.

This year the Committee decided to invest the sum of \$10000.00 in a term Deposit, to generate additional income. In addition we are using the Pay Pal system for members to pay for items on the Distribution list and also to pay their yearly subscriptions.

The Association does not own any property and does not have any mortgages, charges or securities.

### **Summary of 2006**

This year, the first as editor of *Table Talk* has been challenging and extremely rewarding. There have been some significant issues to report and record during the year including the Commonwealth Games, the rise and fall of OzJet, the expansion of JetStar, innumerable changes to the express coach industry and questions over the future of the Tasmanian rail system and ongoing problems with transport sustainability in NSW.

The most gratifying change from the previous year has been a considerable increase in the number of contributors—although it must be admitted that some of them did not know they were writing for The Times when they put pen to paper— some of them are even now dead! The list of authors is, however, still unfairly dominated by the Editor, although he has a considerably lesser dominance than that found in our sister publication in the USA- “*The Time Table Collector*”. Some of these articles were ones I decided to write for their own sake, but many were ones I felt I had to write to fill up the magazine when contributions from others were in short supply.

There has been little change in the number of articles, although the proportion that were *Letters to the Editor* has tripled, a gratifying increase. Former Editor Graham Duffin reckoned that *Letters to the Editor* were the principal item of interest in a magazine, because they reflected what the members’ interests really are. The proportion of articles that is rail-related has increased again from 47% to 56%, which is a bit of a worry, since so many of our members these days are bus-focussed people, especially in NSW. I would encourage them to contribute and not let us rail nuts get the upper hand! The proportion of pages devoted to Australian issues has increased again from 71% to 84%, in line with views expressed a couple of years ago that non-Australian articles appeared to be muscling their way in. Fewer than one-quarter of members have indicated on their application forms that they are interested in Australian timetables only, so we have now probably reached the right balance in The Times.

Both The Times and Table Talk are budgeted to be 16-page publications but, as Table Talk has frequently been less than this, it has been possible for The Times to be expanded to 20 or even 24 pages, without impacting on the annual AATTC budget.

There is not a lot of feedback about whether we are doing the right thing with The Times, although the amount of negative feedback is gratifyingly small— zero even. I am mindful of the fact that most members regard Table Talk as the flagship magazine of the Association and thus The Times may not have levelled against it the scrutiny it deserves. Letters to the Editor are a good indication that people are reading the magazine and their content is never “critical”, but nearly always in the form of expanding upon what has appeared in the articles. The Editor’s own series on “Timetabling Revolution” in 2005 were a case in point, where this attracted the attention of a non-member contributor who was able to greatly expand on our collective information about railway timetabling history in South Australia

In conclusion, I would like to thank the authors, letter-writers and the proof-reading team, for all the work they have put into The Times throughout the year. They have helped make it something which I feel people look forward to each month.



# Production Manager's Report 2005-2006

**GEOFF LAMBERT**

Production of the AATTC's material—The Times, Table Talk, the Auction catalogues, Members Newsletter, survey forms, the Distribution List and miscellaneous printed guff—seems to have run smoothly again this year. Once again, we were forced to change our printer when our existing printer's business was abruptly wound up. Luckily the transition was incredibly smooth and there were no delays in printing. I feel the printing quality of a new printer is even better than that of our two previous printers. The pricing structure was somewhat erratic early on, but now seems to have stabilised.

Production of AATTC's magazines, auction catalogues and other publications is our major cost, totalling over \$11,000 in 2005-2006. This exceeds the income from membership fees by a substantial amount—the AATTC can only run a balanced budget by drawing on other income sources such as auctions.

It should be noted that most AATTC material is prepared in full colour, but the printers are instructed to make the production in black and white. Further, AATTC printed material is produced by what is essentially a photocopy process, which holds prices down. Recently, AATTC was approached by another printer competing for the business and, for a fully offset printing job quoted prices 4 times what we pay now and, for colour nearly 3 times as much again. Full colour, but lower-resolution, versions are available on the AATTC web-site after a prudent period.

All AATTC production is now done electronically and source material is sent to the Production Manager via e-mail. Material is submitted to the printer on CD-ROM. There is thus no particular reason why the Production Manager cannot be anywhere in Australia, though it is an advantage to have them located in a city which would minimise postage costs— which would probably favour Melbourne. Melbourne, however, did the production for about 20 years, so it would be fair to retain production in Sydney for the moment. It is probably an advantage for the Production Manager and one of the Editors to be the same person.

I would like to thank all those who helped with production, including Duncan MacAuslan, Victor Isaacs, Judy Lambert, to whom we owe a special debt—for it is she who must face *Mr Grumpy* at Australia Post on the first Monday of every month.

# Distribution Officer's Report 2005-2006

**LEN REGAN**

During 2005-06, 14 Distribution Lists were prepared, one in each month and two in December 2005 (Overseas Items) and June 2006 (Collection Gap Filler 1: Sydney Buses). Full details of the Distribution List Activities are shown in the Table on the following page.

## **Activities**

A total of 428 orders were placed during the year by 78 participants at an average of 30.4 per list or 35.7 per month. No-one ordered from all 14 Lists, but 8 participants ordered from 13 Lists.

The most popular items were railway working timetables, sets of train and bus timetables, and Timetables on CD. Seven sets of Timetables on CD were offered, attracting a total of 131 orders.

Railway working timetables were offered both as print copies and computer files, and both proved popular despite the high postage costs for the print copies. Many were available as loose leaf copies which were photocopied to meet the demand. This had a big impact on photocopy costs.

Extensive quantities of current material from United Kingdom and Europe were offered in the Distribution Lists from December 2005 to June 2006. The value of orders placed for this material was \$316.75, just slightly greater than the postage costs of getting the material to Australia.

Large amounts of new material were attracted to the Distribution Service through the offer to pay for the postage costs. The Distribution Service also bought several items such as Fares Manuals and Public Transport Guides, and it contributed to the cost of buying the Coyle Collection in Brisbane.

## **Finances**

As an operational activity, the Distribution Service made a profit of \$380. The target set for the Distribution Service when it was revamped in early 2005 was that it covers its operating costs.

The cost of printing the Distribution Lists for the year (\$1788) is seen by the Committee as a corporate expense, as it is a service offered to all members. The cost of each Item supplied by the Distribution Service would have had to increase by 26 cents to fully cover the cost of this printing. This would have increased the cost of the average order by \$3.44.

PayPal was introduced as a method of payment for orders in December 2005 and has proved to be convenient for those with access to this facility. 15% of total payments for the year were made using PayPal.

## **Support Services**

The work undertaken by Hilaire Fraser and Geoffrey Clifton in obtaining multiple copies of timetables from operators, by Roger Wheaton in distributing Adelaide material, and by Kyle Threlfo who helps with the despatch of orders and compiles the Collection Gap Filler lists, is a significant contribution to the effectiveness of the Distribution Service.

The Distribution Service would not be able to operate without the contributions of material from members around Australia, of whom there are many. Special thanks are extended to regular contributors Barry Blair, Bruce Cook, Scott Ferris, Stephen Gray, Steven Haby, Craig Halsall, Ian Hammond, Victor Isaacs, Geoff Lambert, Dennis McLean, John Mikita, Michael Marshall, Vic Solomons, Michael Smith, Peter Walhouse, David Whiteford, and to those who responded to requests to obtain particular items for the Distribution List.
